E GATE SYSTEM IN LIBRARY



Affiliated to the University of Calicut & Managed by the Diocese of Palghat

An e-gate system in a library is a security system that uses RFID (Radio Frequency Identification) or biometrics to manage entry and exit for library users.

Users approach the e-gate and present their RFID to verify their identity. The e-gate displays the user's name, department, and photograph. Users can then enter or exit the library.

The e-gate system integrates with library management software to track entry and exit details and it prevents unauthorized removal of books by triggering an alarm when a patron tries to exit with an unauthorized book. Restricts entry to specific areas based on user permissions .Generates statistics and reports on attendance, user logs, and other data
